



ESSENTIAL SAFETY RULES AND TIPS FOR TRAVELLING IN THE IRKUTSK REGION

In order to make your stay pleasant and safe on the territory of the Irkutsk region the Agency for Tourism of the Irkutsk region recommends:

1. to deal with official tour operating companies and tour agencies that are listed in the Unified Federal Register of Tour Operators https://ev.economy.gov.ru/lk_exp/registry/?region=38

Tour operators and travel agencies are responsible for providing relevant and reliable information on:

- entry and exit requirements for the country (travel destination) of temporary residence, including information on visa requirements and application procedures;
- the main documents which are required for entry into and exit from the country (travel destination) of temporary residence;
- dangers, including health, security and safety risks, that tourists may encounter when travelling on the territory;
- customs, border, medical, sanitary-epidemiological and some other regulations;
- national and religious characteristics of the country (travel destination) of temporary residence;
- some other specific features of the trip.

2. to deal with travel guides and guides-interpreters who are listed in the Unified Federal Register of Travel Guides and Guide-Interpreters https://www.economy.gov.ru/material/directions/turizm/reestr_turizm/reestr_ekskursovodov_i_gidov_perevodchikov/, and have a special badge that proves their tourist guiding qualification. Individuals acting as travel guides or guide-interpreters must be only citizens of the Russian Federation.

3. while planning an active and adventurous tours it is essential to deal with outdoor activity instructors listed in the Unified Register https://www.economy.gov.ru/material/directions/turizm/reestr_turizm/provodnik/ or in the Register of the Irkutsk region <https://disk.yandex.ru/i/MhWAYmlVQxEUWw>

4. to consider accommodations wisely and choose means of accommodation (hotels, guesthouses, hostels, etc.) listed in the Unified register <https://tourism.fsa.gov.ru/ru/resorts/showcase/hotels?regionIdList=38>
